Valuetronics is an Electronic Manufacturing Service (“EMS”) provider, which focuses on the design and development of products that meet the ever-changing customers’ needs. We are the preferred choice of some successful global companies involved in consumer electronics as well as industrial and commercial electronics products, with core competencies ranging from tool fabrication, injection moulding, metal stamping, machining, surface mount technology (“SMT”) and finished product assembly on full turnkey basis.

The Group classified its EMS business into 2 reportable segments, namely consumer electronics products (“Consumer Electronics”) and industrial and commercial electronics products (“Industrial and Commercial Electronics”).

Review – 3 months ended 31 December 2015 (“Q3 FY2016”) vs 3 months ended 31 December 2014 (“Q3 FY2015”)**Revenue**

Revenue decreased by 27.1% or HK\$161.7 million from HK\$596.2 million in Q3 FY2015 to HK\$434.5 million in Q3 FY2016.

Industrial and Commercial Electronics revenue increased by 24.9% to HK\$293.5 million (Q3 FY2015: HK\$235.0 million). Such increase was mainly contributed by the increase in demand from some of our Industrial and Commercial Electronics customers and a new customer within this segment.

Consumer Electronics revenue decreased by 61.0% to HK\$141.0 million (Q3 FY2015: HK\$361.2 million), which was mainly due to the decline in sales of LED lighting products as mass market LED light bulbs (comprising 90% of LED lighting products) have reached end-of-life cycle. In fact, we have completed all the orders of mass market LED light bulbs and have since ceased production of mass market LED light bulbs in this quarter.

Gross profit and gross profit margin

Gross profit decreased by 15.8% to HK\$70.5 million (Q3 FY2015: HK\$83.7 million), however gross profit margin improved to 16.2% (Q3 FY2015: 14.0%). Improved gross profit margin was mainly due to a change in product sales mix during the period.

Other income

Other income decreased by 73.4% to HK\$1.4 million. Such decrease was mainly due to recognition of exchange losses with respect to the depreciation of Renminbi during the period.

Selling and distribution costs

Selling and distribution costs decreased by 12.4% to HK\$7.5 million. Such decrease was mainly due to continuous strict control in marketing expenses.

Administrative expenses

Administrative expenses was HK\$36.1 million (Q3 FY2015: HK\$35.3 million).

Profit for the period

As a result of the above, the net profit for the period decreased by 35.8% to HK\$25.2 million. (Q3 FY2015: HK\$39.2 million).

Review – 9 months ended 31 December 2015 (“9 months FY2016”) vs 9 months ended 31 December 2014 (“9 months FY2015”)**Revenue**

Revenue decreased by 18.3% or HK\$339.4 million from HK\$1,850.5 million in 9 months FY2015 to HK\$1,511.1 million in 9 months FY2016.

Industrial and Commercial Electronics revenue increased by 21.2% to HK\$850.9 million (9 months FY2015: HK\$702.3 million), which was mainly due to the increase in demand from some of our existing and new Industrial and Commercial Electronics customers.

Consumer Electronics revenue decreased by 42.5% to HK\$660.2 million (9 months FY2015: HK\$1,148.2 million), which was mainly due to the decline in sales of LED lighting products as mass market LED light bulbs (comprising 90% of LED lighting products) have reached end-

of-life cycle. In fact, we have completed all the orders of mass market LED light bulbs and have since ceased production of mass market LED light bulbs in Q3 FY2016.

Gross profit and gross profit margin

Gross profit decreased by 8.1% to HK\$226.0 million (9 months FY2015: HK\$246.0 million), however gross profit margin improved to 15.0% (9 months FY2015: 13.3%). Improved gross profit margin was mainly due to the change in product sales mix during the period.

Other income

Other income decreased by 68.3% to HK\$3.8 million. Such decrease was mainly due to the recognition of exchange losses with respect to the depreciation of Renminbi during the period.

Selling and distribution costs

Selling and distribution costs decreased by 29.0% to HK\$20.0 million. Such decrease was mainly due to continuous strict control in marketing expenses and write-back of provision for sales warranties amounted to HK\$3.4 million.

Administrative expenses

Administrative expenses was HK\$107.9 million (9 months FY2015: HK\$105.4 million).

Profit for the period

As a result of the above, the net profit for the period decreased by 16.9% to HK\$90.9 million (9 months FY2015: HK\$109.4).

Financial position and cash flows

As at 31 December 2015, the Group had net current assets of HK\$574.5 million (31 March 2015: HK\$559.1 million), total assets of HK\$1,526.3 million (31 March 2015: HK\$1,522.7 million) and shareholders' funds of HK\$828.4 million (31 March 2015: HK\$808.5 million).

The Group's trade receivables decreased by HK\$163.8 million from HK\$517.0 million as at 31 March 2015 to HK\$353.2 million as at 31 December 2015. The Group's trade payables decreased by HK\$27.7 million from HK\$347.4 million as at 31 March 2015 to HK\$319.7 million as at 31 December 2015. The Group's inventories decreased by HK\$10.0 million from HK\$221.9 million as at 31 March 2015 to HK\$211.9 million as at 31 December 2015.

The working capital of the Group as at 31 December 2015, which is the sum of trade receivables and inventories less trade payables, was HK\$245.4 million (31 March 2015: HK\$391.5 million). The decrease in net working capital, reflecting the movement in trade receivables, inventories and trade payables, was in line with the drop in revenue during the period.

With the strong free cash flow generated by the Group, total cash increased from HK\$505.8 million as at 31 March 2015 to HK\$681.8 million as at 31 December 2015 after the distribution of cash dividend of HK\$75.5 million. Over 96% of its cash and cash equivalents were placed in reputable financial institutions in Hong Kong. The Group had no bank borrowings as at 31 December 2015 (31 March 2015: Nil). For the remaining balance, mainly in PRC, the cash and cash equivalents were placed in equivalent reputable financial institutions. The cash and cash equivalents are annually audited by the Group's auditors.

During Q3 FY2016, Valuetronics continued to benefit from the widened customer base in the Industrial and Commercial Electronics (“ICE”) segment, and the growth in this segment has mitigated the decline in Consumer Electronics (“CE”) revenue. Overall gross profit margin improved slightly with increased weightage in ICE segment. Our working capital remained healthy with operating activities generating positive operating cash flow.

ICE segment continue to achieve double digit growth during the period with revenue growth from some of our existing customers as well as new revenue stream from the production of electronic products for automotive industry.

CE revenue in this quarter comprised predominantly consumer lifestyle products as we finished all the last orders for the mass market LED light bulbs. With no more mass market LED light bulbs in production, our CE revenue will now comprise products with consumer applications for a portfolio of customers.

While we are well positioned to take advantage of a widened product portfolio and opportunities in the pipeline, we remain mindful on the impacts on the overall business which may result from a stronger US dollar, a continuously depreciated RMB and a further slowdown in China’s economy. Barring unforeseen circumstances, the directors expect the Group to remain profitable for the financial year ended 31 March 2016.
